#### Additional Consideration that can impact inclusion on final passport

- Customer Volume
- Price Range Variety
- Geographic Representation: Consideration will be given to ensuring businesses reflect Colorado's diverse regions and tourism offerings.

- Ownership: Consideration will be given to ensuring businesses reflect Colorado's diverse communities.

#### **Selection Process**

Interest forms are first vetted through an internal compliance review to ensure they meet the mandatory eligibility criteria and that all required materials have been submitted. Incomplete or ineligible interest forms will be rejected. Mandatory criteria are:

- Business must be tourism related
- Business must be physically located located in Colorado
- Businesses must have wi-fi or cell service on-site
- Business must be visitor ready (i.e. regular, posted hours of operation; fully staffed)

Eligible business requests will be reviewed and selections will be based on merit, available spots, and final Commission approval.

The interest forms will be evaluated on these merit-based criteria:

- Promotion commitment to promote the passport program on own channels
- Visuals ability to provide promotional photos
- Incentive Offers level of incentive offered
- Ties to History strength of the business ties to the history of the area and the story of Colorado

The America 250 - Colorado 150 Commission reserves the right to select and approve businesses which best meet the objectives and requirements of the passport program and demonstrate the greatest potential to meet program goals and objectives.

Reviewers will prioritize the following:

- Geographic Representation: Consideration will be given to ensuring businesses reflect Colorado's diverse regions and tourism offerings.
- Customer Volume: Consideration will be given to the number of patrons who frequent the business
- Price Point Variety: Consideration will be given to ensuring businesses represent a variety of price points to cater to visitors/different customer segments with varying budgets and needs
- Consideration will be given to ensuring businesses reflect Colorado's diverse communities.
